NOTICE OF SETTLEMENT APPROVAL HEARING FOR CANADIAN MEDTRONIC SPRINT FIDELIS LEADS CLASS ACTION

PLEASE READ CAREFULLY. IGNORING THIS NOTICE WILL AFFECT YOUR LEGAL RIGHTS

WHO IS THIS NOTICE FOR?

This Notice is directed to Canadians who are Class Members in a Class Action related to certain ICD Leads manufactured by Medtronic, Inc. and/or Medtronic of Canada Ltd. The Class Action includes all persons who were implanted in Canada with one or more Sprint Fidelis Leads that have the following Lead model numbers: 6949, 6948, 6931, and 6930 ("the Leads").

The Canada-wide Class Action lawsuit alleges that the Defendants were negligent in the design and manufacturing of the Leads. On October 2, 2009, the Court certified the Leads Class Action as a class proceeding and the time to opt out of this action has passed.

The parties in the Class Action have reached a proposed Settlement ("the Settlement"), subject to approval of the Court. This notice provides a summary of the proposed Settlement.

WHAT IS THE PROPOSED SETTLEMENT?

The proposed Settlement provides for a \$26 million (CDN) Settlement Amount which will be used to pay Approved Claims, the claims of the Public Health Insurers in the amount of \$4 million (CDN), the costs of notice and administration, representative plaintiff honoraria, and Class Counsel Legal Fees, disbursements, and taxes. If the Settlement is approved, and subject to the total number of Approved Claims, payments of up to \$25,000 will be made to Class Members who establish that they had a Lead that was prematurely explanted/replaced (or that they experienced unintended shocks) as a result of a fracture/impending fracture in the Lead.

Further compensation may be paid to Class Members who experienced additional medical complications related to the Lead fracture. The quantum of compensation paid will depend on the total number of Approved Claims and all payments will be inclusive of all Family Class Members' claims. Not all Class Members will be eligible for compensation. If money remains after the payment of all Approved Claims, the payment to the Public Health Insurers, the costs of notice and administration and Class Counsel Fees, disbursements and applicable taxes, such funds will be re-distributed proportionately among all Approved Claims.

RicePoint Administration Inc. has been appointed by the Court as the Claims Administrator for various pre-approval purposes and will be proposed as the Claims Administrator for the Settlement. THE PROPOSED SETTLEMENT REQUIRES COURT APPROVAL

In order for the Settlement to become effective, it must be approved by the Court, which must be satisfied that the Settlement is fair, reasonable, and in the best interests of Class Members. The Approval Hearing has been scheduled as follows:

March 2, 2020 at 9:00 a.m. at Osgoode Hall, 130 Queen St. W., Toronto, Ontario.

OBJECTING TO THE PROPOSED SETTLEMENT AND OPPORTUNITY TO APPEAR

If you wish to object to the proposed Settlement, you must submit a written objection to the Claims Administrator by **no later than February 24, 2020** at the address listed in this Notice. The Claims Administrator will file copies of all objections with the Court. **Do NOT send an objection directly to the Court**.

You may also attend the hearing on the date noted above, and if you have submitted a written objection to the Claims Administrator, you may make oral submissions.

PARTICIPATING IN THE SETTLEMENT

If the proposed Settlement is approved by the Court, Claimants will have a limited amount of time within which to submit a Claim. However, downloadable versions of the Claim Packages are now available online at **www.medtronicleadsettlement. ca.** Claim Packages can also be requested from the Claims Administrator.

If you intend to submit a claim under the proposed Settlement, you must do so on or before the expiry of the Claim Period, which will be posted on the Claims Administrator's website.
